

Amana Brand 2024 Consumer Financing Program – U.S. & CANADA

Eligible Participants and Timing:

This program is eligible for a licensed independent Amana Heating and Air Conditioning Brand Dealers in the U.S. and Canada. The standard buy down will run year-round, but claims must be submitted by the end of each quarter per the guidelines below.

- U.S. or Canadian Homeowner must purchase eligible equipment and execute a consumer financing contract with an EGIA lender between **April 1, 2024 and June 30, 2024**.
- Licensed independent dealer must **install qualifying equipment between April 1, 2024 and July 15, 2024**
- All consumer financing contracts **must be funded by EGIA by July 15, 2024**.
- All buy down **rebate claims must be submitted by July 15, 2024**.
 - Late claims will be paid out at 50% of the dealer rebate amount only for a short period after the initial deadline. Any late claims will be paid at Goodman Manufacturing's discretion.

Standard Amana Financing Buy Down - Qualifying Amana Brand Equipment

- Installation of a complete Amana Brand HVAC "system" is not required. See eligible product matrix* for full details.
- To qualify for the Amana Brand 2024 financing buy down, the consumer financing contract must include either:
 - **6% Buy Down Rate**
 - **Amana S Series (ASXS6, ASZS6)**
 - **3% Buy Down Rate**
 - AVXC20, ASXV9, AVZC20, ASZV9, AVZC18, ASXC18, ASZC18, ASXC16, ASZC16, ASXC7, ASZC7, ASX16, ASZ16, ASXH5, ASZH5, AZXH5 Outdoor Unit OR
 - AMVM97, ACVM97, AMVC96, ACVC96, AMVC8, ACVC8, AM9C96, AC9C96, AMES96-U, AMES80-U Indoor Unit OR
 - AM9S80-U or AM9S96-U (California only)
 - AHVE, AVPTC, AMVT, AVPEC, AMVE, MBVC Air Handler
 - APG16M, APGM5, APHM5, APH16H, APH16M, APD14M, APDM3 Packaged Unit
 - **QMVJU Aurora Single, UMVJU, WMVJU, or MXL Multi-split, MXS Multi-split, or LV Series Ductless System**

Standard Amana Financing Buy Down through EGIA

- Consumer financing buy down is fulfilled by a buy down rebate to the Amana Brand Dealer for eligible equipment* on any approved plan type.
- If the standard dealer discount rate is less than 3% (or 6% where applicable), the rebate will be calculated based on that lower discount rate.
- Example below:
 - Amount Financed: \$12,500
 - Standard Dealer Discount Rate: 7.25% = \$906.25 discount rate amount paid by dealer
 - Amana Brand Discount Rate participation rebated to dealer: **3.0% = \$375**
 - Net Promotional Dealer Discount Rate: 4.25% or \$531.25 net amount paid by dealer
- **Amana buy down can be applied across any EGIA plan type with any EGIA lender.**
- Financing offers apply only to Amana Brand qualifying equipment* financed under the EGIA program.

Consumer Financing Details:

- Amana 2024 Consumer Financing Plan(s) buy downs are available in the US and Canada through EGIA lenders only. Any other lenders will not qualify for a buy down.
- Amana Brand Dealer must be approved and in good standing with EGIA prior to offering Amana brand Financing Offers to Homeowners.
- Finance contracts are subject to a \$15,000 USD / \$15,000 CAD maximum retail sale amount.
 - **Amana Inverter Unitary & S Series are subject to a \$25,000 USD / \$25,000 CAD maximum retail sale amount.**
- Sales amount used to calculate financing buy down rebate excludes taxes.
- All EGIA plans are subject to applicable origination fees and credit card processing fees.
- Homeowners are subject to credit approval by EGIA or their approved lenders.

EGIA Rebate Claims Process

- Amana Brand Dealer is “funded” by EGIA for each qualifying job, less appropriate EGIA discount cost plus any applicable credit card processing fee.
- **Amana Brand Dealer is responsible for submitting the consumer financing rebate claim and all supporting paperwork to EGIA by April 15, 2024.**
- Consumer Finance rebate claims will be entered online at https://www.egia.org/directory/partners/amana/#rebate_application.
- All required consumer financing back-up paperwork must be sent to EGIA via www.egia.org/amana by the Amana Brand Dealer. EGIA or Amana Brand Heating and Air Conditioning are not responsible for lost/missing paperwork.
